Present: All members of the committee except Bob Starzyk
Joining call: Kris Syrdal, Dave Wojahn, Lonnie Priest and Pete Phillips
John Steed called the meeting to order
The October Minutes were approved

2017 Kris Syrdal reported the Hotel is doing a major renovation and it is very attractive. Roy reported that registrations have been slow. It was suggested that more promoting is needed both in the Bugle and with the Forum. As an alternate to one of the trips it was suggested that the Kissell Museum is outstanding. The subject of T-shirts have been a sore point with both Kris and Kirt. This discussion will be continued later in the meeting.

2018 Kirt Priest: Responsibilities have been divided, and more information will be forthcoming after the 1st of the year. The Marriott contract has been signed and the agreement with the lot next door presents no problem. 375-400 cars are expected.

2019 Pete Phillips reported on the Tower Hotel in Oklahoma City and the location on the NW side of town. The BCA will be sharing with another car club, therefore there will be two car shows off site at a church approximately three miles apart from the hotel. Judging will be on Friday and the Banquet on Saturday. The number of cars expected will be similar to the Number at Springfield. (334). A motion made by Bill Stoneberg and seconded by Jack Welsh to

approve going to Oklahoma City in 2019 was passed by a unanimous vote. The dates will in May or June but not after the First week in June. Pete Phillips is now a member of the National Meet Committee.

2020 Both Atlanta and North Central Ohio are indicating interest in having a National Meet.

Discussion followed about the importance when working with Helms Briscoe that careful attention should be paid when dealing with the hotels. There can be serious financial risks involved.

The subject of T-shirts has been a sore point with both Kris and Kirt. Kris related in detail how unsatisfactory the contacts with Dave Leash have been. Leash could not provide print ready graphics so Tim Coy was hired to provide the graphics which cost them \$1,000. This was something that Dave Leash's company provided in the past. Leash gave them the run-around and provided nothing, therefore Kris and her group had no shirts at Allentown. Selling shirts at the meet before your meet is one of the best places to sell shirts. Now the Brookfield show has lost this opportunity.

Brian Clark is to contact Mike and the BCA Office on Monday the 21st and work out something to release the Denver Meet from the contract with Leash. The NMC would like the National Meet apparel to be excluded from future contracts for BCA apparel. This contract is up for renewal in September 2017.
