Subject: National Meet Parking for Prewar Buicks

In keeping with BCA Standard Operating Procedures, I hereby notify the BOD of our intent to park all PWD Buicks in chronological order at all future BCA National Meets.

During registration for a BCA meet, BCA members may join the PreWar Division at no charge and park chronologically regardless of judging classification. Due to the limited number of participants and only four judging classes for prewar cars, I am confident that this will not significantly affect judging procedures. I will be glad to coordinate with the National Meet Director to accomplish this. Hopefully, this will resolve the long standing issues our members have had with previous National Meet parking requirements. Please respond to the writer via email with any questions or concerns.

Procedure #5

Buick Club of AMERICA Standard Operating Procedures:

- 4.1 National Meets: Members of a Division are encouraged to present their cars at the annual BCA National Meet.
- 4.1.1 There may be a class or classes for the Division's cars on the show field.
- 4.1.2 The Division will develop the method by which the Division's cars are judged and by which awards are presented to cars in that Division.
- 4.1.3 The Division's officers are encouraged to work in conjunction with the host National Meet Director to organize other activities at the National Meet related to their member's area of interest, such as: seminars about the cars, their features, maintenance and operation requirements, etc.
 - 12/22: after several additional e mails with questions about the intent of the 11/30 e mail, decisions, and degrading discussions, A. Oldfield calls for a holiday truce to provide a cooling off period, and resumption of the discussion after the holidays, with respect shown to all parties involved.
 - 1/26: As of today, there was agreement that set up of the show field in Denver would attempt to include a contiguous location for all cars in the four pre-war classes, A,B,C,&D. There was also agreement that for these four classes, all the vehicles will be parked together for the 400 point, archival, and display registration categories. It is acknowledged that if the Modified Division has its own class, pre-war vehicles registered in that category will be parked with the Modified Division's class. And, there was agreement that vehicles in these four pre-war classes which are registered for Judging, will be judged according to the regular BCA Judging system. The parties have not settled on who would be responsible for accomplishing chronological parking in classes A, B, C, and D, at the Denver Meet, however the parties have agreed to work together to park the pre-war cars.
