2/12: BOD conference call postponed.

2/12: Alan O. writes: Good afternoon. I wish to pass along to you an idea from Cindy for the April Bugle. Cindy has created a mock-up of a cover design for April that may do two things:

- -call attention to the ballot for BOD elections, hopefully encouraging more members to vote; and
- -decrease the likelihood of confusion from the post office (as you know last year, a few ballots were returned to sender because the post office was confused).

The color wrap will cost \$639 for 8000 copies of the Bugle. Please take a look at the attached mockup from Cindy. Here is a bit of explanation from Cindy: "Just small changes, and it's still a work in progress, but you can see the

pages 1, 5, 6 which will appear in color and also how the front and back of the postcard ballot will look. I know it's hard for people to visualize with the front cover turned sideways, but if they get a cover wrap from this last issue, they can get better idea - same format with the ballot in place of the BCA membership application."

I have copied Cindy on this email so you can ask question of her directly. Please take a look and register your thoughts. After discussion we'd need a motion to approve if we want to do that. This is time sensitive. Thank you!

2/14: Alan O states: Everyone, RE: the proposal from Cindy that I sent to everyone earlier - I should note the \$639 cost was for printing only, no charge from Cindy. She did the work at no charge. Since I've heard no response from anyone, I will presume the BOD doesn't want to consider it. Thanks

Bob S states: Alan, I guess this is something that is hard to visualize. If she thinks this would be beneficial to the Club and is not profiting in any way, I would vote yes.

John D States: I think it is a great idea unless the accounting firm objects to separation of the preprinted name? At least I assume the preprinted member name is separated from the return address? Overall it is something different which will draw attention to the vote process and that's good. I would also suggest that the wording of the instructions includes the word "each" within, to make it clear that if the 2nd vote is used, both spouses vote for three candidates, not just three between them. When do you need the BOD's decision? And may I suggest (and ask) if Bill can contact the Accounting firm to run this change past them?

Bill S states: I (C) and o that and will do that today.... And subsequently writes: From Brett: "I agree, it does confuse the post office. It seems that most of the voters don't like there names and addresses on the card. A lot of cards come back with it blacked out or covered. I think having the name or names as the case maybe and the number would be good." So Cindy, I think you are good with what you are doing.

John D states: I'll make the motion: that the Club spends up to \$750.00 for a color wrap for the April 2018 issue of the Buick Bugle.

Brian C. asks: Cindy, is it possible to design it so that the member has to fold the ballot to mail it? That way the mailing (and member verification) label would be hidden on the inside, and the address label on the outside. To which Cindy Livingston replies: Maybe so. The blank box where MLP puts the member mailing address has post office dimension and position requirements, so I'm not sure that will work, but I'll check it out. To be honest, I don't want to spend a ton of time working on a new COLOR design if the board doesn't want to spend the extra money for it, so let's first decide on color or black/white and then I'll work on a design. How about the BOD weigh in and at least give me an idea by Sunday night if they want color or not. From there, I'll get to work on the design. Sound OK?

Ed D. states: John, I would like to see your motion amended along the lines of: And, if the proposed solution minimizes the post office problems in the opinion of ______ that the cost of the changes be incorporated into future budgets. I'm thinking that we should not have to vote on the same concept year after year

John D states: Hi Ed. I can understand your amendment but it calls for someone to analyze the results of this change. First off I don't want that to be me, and secondly it sets up the analysis for immediate contention. What will the responsible party use for a base? And what will they check? We have no real knowledge of how many, if any, ballots were returned by the PO to the members. There is only a few comments on the forum that some people got their ballots back in prior years. This number could be as small as one or two. In the amendment we'd have to certify that

no one got their remailed ballot back from the PO, and how would that be accomplished? As to future Bugle budgets this cost can simply be added to the budget each year with so much as a pen stroke. A motion would require it each year. What happens when Cindy resigns? It could be a bone of contention then. So I am not really in favor of amending this motion and besides, if no one seconds it, it's not really a motion anyhow. One more thought. To me, the value of this is the change to the ballot and the emphasis on getting members to vote. Making it more obvious to the PO where the remailed ballot should be sent is just a worthy side benefit.

2/15: Bill S. states: I think Cindy has gone out of her way to help us. I think the original design and color is a big improvement over what we have done in the past. Hopefully it will get us more voters....In that regards, and the fact that we will spend more money, I want (t) see a vote. I also want to see the national Meet ads printed in color. So I second John's original morion (Motion) to print this in color. Assigned Motion # 2017-2018-22.
