2. 2000 BCA National Meet Update

Meet Chairman Phil Strassner reported there were 520 members registered, with 323 total Buicks, of which 240 were to be judged.

Paul Blackbourn, Buick Club of England, questioned why information from their Club doesn't appear in The Bugle.

John Ball also requested the Board notify all non-winning Board of Directors election candidates in writing as soon a practically possible after the election with results. It was suggested this be included in SOP #13.

There was also discussion concerning non-BCA members registering to attend BCA National Meets and partaking in various tour-type events. The Board will be reviewing policy regarding this issue.

Treasurer Cecil Don referred the Treasurer's Report to Joel Gauthier, BCA Accountant. Joel presented a written report. (Appendix B)

6. Committee Reports

Office Managers Report

Office Manager Val Ingram was not present. No report was submitted.

Editor's Report

Bugle Editor Chuck Koch was not present, but submitted a written report. (Appendix C)

Total expenses for the year exceeded projections by \$4481 (2%). Total copies printed exceeded projections by 550, and postage costs are \$4047 more than last year.

Higher ad content (BCA Store catalog, other free ads) raises postage costs.

Advertising revenues were higher than projected by \$659, and surpassed last year by \$203.

Chapter Coordinator Report

Chapter Coordinator Judy Leets reported receiving a request to consider forming a Park Avenue Owners Club. Information on how to do so has been forwarded to the requester.

Ron Herrman, Central Oklahoma Chapter, has expressed interest in forming a new Chapter in the Tulsa, OK area. An application has been forwarded.

Regional Coordinator's Report

Regional Coordinator Strassner presented a written report. (**Appendix D**)
Nancy Thompson will be assuming the duties of NorthEast Region
Director in late summer/early fall.

Cecil Don will occupy the seat of Regional Director for the new California/Nevada Region.

Steve Ledger will continue as Heartland Region Director.

David Corbin will assume the duties of Regional Director in the new South Central Region.

Internet Report

President Vasilow reported she is continuing to investigate sources for a new server for the BCA WebSite. Adding the BCA Roster to the WebSite is also under consideration, as well as adding membership renewal capabilities via the internet.

Technical Advisor's Committee

Director Schoening reported all is going well with the 72 advisors currently on staff. A new Web update is coming soon. Bill reminded all that the Tech Service is for BCA members ONLY, and requesters MUST give their BCA number when contacting for information.

Chief Judge's Report

Chief Judge Mac Blair reported that the Judges Handbooks would be distributed at the Judges Training meeting.

Resolved: To request Mac Blair and Rick Schick streamline distribution of the Judges Handbook and make a recommendation to the Board at the October 2000 meeting on the best way to handle the Handbook in the future.

Motion by Brashares Second by Schoening Vote: Approve - 7, Disapprove - 0

Questions were raised on whether to create separate classes for Grand National and Grand Sport. It was determined to allow the Meet Chief Judge to make the decision on a meet-to-meet basis.

Resolved: To add a permanent "Class Q" for Grand National, Turbo T-Type Regal, and GNX. To be sub-divided, as required, at the discretion of the Meet Chief Judge

Motion by Eichelberger Second by Brashares Vote: Approve - 7, Disapprove - 0

Questions were raised concerning distribution of Archival and Senior awards. It was concluded the awards would continue to be mailed.

Director Brashares has provided the Board with a computer database which identifies all persons who have served as Judges at BCA meets from 1989 through 1999.

Resolved: To appoint Keith Bleakney as Chairman of the Judges Records of the BCA. He is to maintain records of all persons who have served as Judges at BCA National Meets. The appointment is subject to the same term limits as Chief Judge and Judges Training Chairman. Copies of all records are to be sent to the BCA National Office, Chief Judge, and BCA President.

Advertising Agent's Report

Jim Cain was not present. No report.

BCA Store Update

Carol Serrone-CPA, Plante & Moran, LLP, presented a written and verbal report. (**Appendix E**)

Resolved: By the October 2000 Board meeting, have in place a BCA Chapter, or group from a Chapter, willing to take over the operation of the BCA Store within a structure that will incur NO financial loss to the BCA. All items are to be on consignment, and the minimum commitment is to be three years.

If no suitable entity can be in place by October 21, 2000, it is recommended the BCA Store be closed.

2000/2001 Budget/Audit Update

Carol Serrone-CPA, Plante & Moran, LLP, is continuing to work on completing a BCA financial audit.

Director Brashares announced the BCA has lost nearly \$48,000 during the past two years.

Major expenses are: BCA Roster, Judges Handbook, BCA National Office Operation, and The Buick Bugle.

It is expected the new Bugle can be edited, printed, and mailed for the same, or less, than in prior years. A thirty-day termination clause is in effect with Baker Press.

Brashares suggested an RFQ be written for the BCA National Office, and the operation of the office be put out for bids.

Much discussion and many concerns have been raised by the BCA membership regarding an across the board dues increase. Brashares stated, based on cost vs. income studies, that unless dues were raised immediately the BCA could not survive.

Resolved: To raise the BCA membership dues by \$5 across the board, effective October 1, 2000.

Motion by Brashares Second by Eichelberger Vote: Approve - 7, Disapprove - 0

Effective October 1, 2000, BCA membership dues are as follows:

1 year \$35 2 years \$65 3 years \$95 Lifetime \$700

Director Brashares pointed out the BCA spent \$99,000 on administration costs for approximately 10,000 members in 1999. That is an average of \$9 per member.

Resolved: To write an RFQ on the operation of the BCA National Office, which would include all expectations within it's structure, including what the BCA is willing to pay for said operation.

Val Ingram, current BCA Office Manager, would be invited to respond to the RFQ. This RFQ is to be ready for approval by the October 2000 Board meeting.

Brashares provided a cost figure of approximately \$22,000 per issue, plus mailing expenses, to produce the BCA Roster. It was suggested the Board consider input from the membership present at the BCA General Membership Meeting of July 6, 2000, at the BCA National Meet before taking any action regarding the BCA Roster.

Resolved: To defer any decisions regarding the BCA Roster until additional input is gained from the General Membership meeting of July 6, 2000.

Motion by Brashares Second by Schoening

Vote: Approve - 7, Disapprove - 0

Carol Serrone and Brashares estimate the 2001 Bugle will cost \$228,861, based on 40 pages per issue. Additional pages are at the discretion of the BCA President and would increase costs incrementally and significantly.

Resolved: To accept The Bugle budget at \$228,861 for 2001, based on 40 pages per issue. Additional pages are at the discretion of the BCA President.

Vote: Approve - 7, Disapprove - 0

Resolved: To approve the 2001 BCA budget (**Appendix F**), excluding the BCA Roster until after considering input from the members at the General Membership meeting of July 6, 2000.

BCA Museum and Archive Foundation

BCAMAF President Roy Wager reported all is going well and invited all members to attend their meeting at 1PM, July 7, 2000.

Editor/Printer Transition to Baker Press Update

Vice-President Ken Liska reported the transition is going very well.

Liska also presented a sample calendar/poster created by Baker Press and being considered for sale to the BCA membership.

8. Unfinished Business

2002 BCA National Meet

The Southern Arizona Chapter and Finger Lakes Chapter have both expressed an interest in hosting the BCA National Meet in 2002.

Submittals to host the Meet must be entered by October 1, 2000. Not staging a National Meet in 2002 is also being considered.

Membership Award

Director Brashares and Chapter Coordinator Leets presented a program that offers incentives for the sponsorship of new BCA members as follows:

- a. Must have a minimum of 3 new memberships per quarter to be eligible.
- b. Chapter members (Chapters are not eligible) with the most memberships per quarter receive a \$25 gift certificate for the Buick Store, or a Buick truck (\$25 value), their choice.
- c. Member who sponsors the most new members during the BCA fiscal year (July to June) will be presented with the Gerstkemper Award at the BCA National Meet banquet or General Membership meeting.
