8/21/2018 President Alan expressed disappointment on this and inquired of the BCA Office as to the cost.

8/21 / 2018 The BCA Office replied that the annual cost was eight thousand five hundred dollars.

8/22/2018 President Alan querys the BOD on whether or not it feels like the BCA should absorb the cost to continue packaging.

8/23/2018 Emails are received from outside the BOD regarding BOD issues (the Bug=le wrapping issue).. Bill Stoneberg and President Alan that BOD matters remain with in the BOD.

This is the reply from the BCA office on the poly bagging. Nancy told me that they usually sent around 20 Bugles a month due to damage. The cost to replace damaged Bulges needs to be compared to the cost of poly bagging. ie $20 \times \$2 = \40 month vs \$8,500 / 12 = \$708.33. Not allowing for the time and effort of Mike and Nancy.
