1/3/2019. President Alan composes letters to BCA members that contacted him about their choice for the BCA office Management position, informing them the Cornerstone Membership Services has been awarded the contract.

1/3/2019 President Alan notifies the Web master of our award as follows:

I want to update everyone on the Board's selection of a firm to supply office management services when Mike and Nancy Book retire at the end of January. The Board met via conference call January 2nd and voted between our two finalists: Cornerstone management of suburban Minneapolis, and Brian and Kim Clark.

The vote was 5-4 in favor of Cornerstone.

My thanks to all the members who wrote to the Board to share their input on the selection process. The transition has already begun in earnest. Look for more information in the next Bugle.

1/4/2019 The BOD received a list of vouchers to be paid by the BCA Office

1/9/2019 Larry D moves to remove Jack Gerstkemper as interim director of the PWD.

1/9/2019 President Alan mentions that Nancy Book has received two quotes from interested audit firms.

1/9/2019 Terry seconds Larry D's motion to remove Jack Gerstkemper as interim director of the PWD.

1/10/2019 The BCA office send the BOD copies off additional vouchers

1/10/2019 Larry D restates his motion to read: **To remove Jack Gerstkemper as the Interim Director of the PWD, recognize the elected National Director of the Prewar Division and print a retraction/update to the January Bugle "PWD 2.0" article in the in the next Bugle stating the same.** 1/11/2019 John Steed calls Larry D's motion out of order as the "floor ' was closed.

1/11/2019 Discussion follows regarding Jack Gerstkemper's role as Interim Director of the PWD and Brian's role as Director and whether or not his election is valid.

1/15/2019 The BOD receives the December expense and income report form the BCA office

1/16/2019 Bill Stoneberg present the November BCA balance sheet as prepared by tour accounting firm.

1/16/2019 Jack Welch states the following: As you know, president Alan had appointed me as a committee of one to act as a mediator in resolving the PWD issue .

It has taken some time and research to provide this report. My findings (as I perceive them) are as follows. The BOD took vote at the Denver National Meet to remove Mark Shaw as Director of the Prewar Division. The reason for this are in the minutes of that meeting. According to the SOPs and bylaws of the BCA, the Divisions are self governing . This would in my opinion render the process used to remove Mark and Install Jack

Gerstkemper to be incorrect. The reasons for their decision were correct, The PWD was in fact not operating with in the guidelines of the PWD as a division according the by laws and SOPs of the BCA.

My opinion is that the BOD should have removed the PWD as a Division. Under the Bylaws, the PWD should have been given thirty days notice to refute the charges.

The Mission Jack Gerstkemper was given by the BOD was to reorganize the PWD and come up with an accurate date base and a set of bylaws. The thought was that an election would be held following that

reorganization. Jack Gerstkemper has been working as requested to make that happen.

An election was held by some PWD members and Brian Heil was elected as the PWD Director. The election was a flawed process in that no accurate data base exists, and all members did not have a chance to participate. There are also no By laws in place to provide guidance for an election process. All of this is causing a giant rift in. the PWD and the BCA and should be ended immediately.

In my assignment as a committee of one, I have been working with both Brian and Jack to resolve this issue. We have all agreed that the only process that will work is for the current BOD to over ride the action taken by the BOD, and to negate the election that just took place. Brian Heil and Jack Gerstkemper have both volunteered will work together to reorganize the PWD by coming up with a legitimate Data Base and a set of by laws for the PWD to be governed by. They will put out a joint statement for the Bugle announcing a PWD Meet & Greet at the Midwest City National Meet and they will encourage PWD members to attend the tours that have been organized by the Host Chapter.

The Motion proposed by Larry D should be declared null and void . I feel that we do not need any further motions but if one is to be put forth it could say that the Actions of the BOD at Denver be revised and that two PWD volunteers, Brian Heil and Jack Gerstkemper should be allowed to continue the process of reorganizing the PWD.

The best course of action for the BCA and the PWD is to ask Larry D to withdraw his motion. Failing that it should be declared out of order.

1/16/2019 Larry D stated:

Jack:

Will ALL BCA divisions now be subjected to this scrutiny?

My first and foremost objection is that a fraud had been perpetrated on the BOD and the membership at Denver. Support of this fraud only confirms those who were complicit in originating it.

In my motion I wanted to present a method to resolve this fraud in an easy manner with the least ill feelings and ability of all concerned to save face.

As you have indicated my motion was declared null and void .

The best course of action for the BCA and the PWD is to ask Larry D to withdraw his motion. Failing that it should be declared out of order.

I can not withdraw the motion that has already been declared null and void and out of order by you, John Steed and Alan Oldfield. So if a motion is to be made it should be made by someone else.

I see that the three of you prefer the hard method. Will these exchanges be part of the BOD business minutes?

1/20/2019 President Alan:

My thanks to Jack Welch for his work on trying to reach a consensus on the pre-war issue last Friday. Here is where things stand:

-Larry's motion was declared out of order for the reasons I articulated. It remains so. We will move one.

-Brian H and Jack G are working together, which is the best outcome. I applaud them for doing so. Let's move on to another important issue.

Attached are two additional audit proposals developed through work done by Nancy Book with assistance by Bob Safrit. My thanks to both of them.

Please review them. Note, in the Borowitz proposal, the reference to "agreed upon procedures" refers to a forensic audit. Nancy, please correct me if I am wrong. Nancy is copied on this email so you can direct questions about these two proposals to her.

Larry or Roberta - I cannot quickly put my hands on the two proposals you developed. Would you please forward them to the entire board again so we all have them for easy access to compare.

1/28/2019 John : The BOD voted to replace a Director that had failed to keep his membership current in the BCA. Our Bylaws require Division members to be members of the BCA. So the BOD decided to remove the Director of the PWD Division for failure to maintain his membership in the BCA. I do not see where the BOD's action was *invalid*. There have been several wrongs in this process and I would agree with Larr; y that the BOD cannot remove a Director without cause. However not being a member of the BCA is cause.

1/28/2019 Larry S: Mark Shaw was a member at the time of the Denver meet. In fact I believe that he had reinstated his BCA membership at least a year before the Denver meet.

1/28/2019: John: The PWD Director accepted that position when the PWD was created. He never gave that position up when he dropped the BCA. He was never elected to that position after he quit the BCA. Therefore it seems the PWD did not follow the Division Bylaws. The BOD does have the right to enforce the BCA Bylaws.

1/29 2019 John seconds the motion

1/29/2019 Larry D; The November minutes look good to me.

I realize that we on the Board gave Jack some leeway in editing down the minutes for expediency. Although some of the entries are quite cryptic it is hard to understand what was exactly being referenced.

1/29/2019 Jack : Larry D

The minutes from Denver already include Jack Gerstkemper 's statement. I feel no need to include info that is not on my "watch" and that already been documented.

It is my belief that I captured your opinion about working with Jack G in my statement . I feel that minutes are to be a description of actions taken by the BOD and need not always detail in depth full conversations and comments

1/29/2019 Larry D: I did not ask you to include my entire email response. I would just like that your interpretation reflect what I intended. Possibly

to be simply worded as below."*in my view this (Jack Gerskemper's report) not to be even considered on its validity*".

1/20/2019 Jack :fair enough Larry

1/30/2019 President Alan: Moved by Jack, seconded by John Motion to approve minutes as submitted by our secretary

1/30/ 2019 John Votes yes

1/30/2019 Larry D I am ready to vote approval only if we see a revised set of the October minutes reflecting the corrections I asked for.

1/30/2019 Jack : I had already agreed to that

1/30/2019 Terry; you had already agreed to what? I am missing something here. Please explain in detail for us all.

1/30/2019 Jack I had agreed to Larry D's request for a slight revision to my wording of one of his statements in the Oct. draft minutes regarding Jack G' PWD report

1/30/2019 Larry D: All I asked for was a revised set of just October's minutes for us ALL to see what was changed. So let us see. Then we can continue voting.

1/30/2019 Larry D: Let us see.

1/30/2019 Roberta : Two fixes for the Nov Minutes. Typo RQG should be RFQ and the Chapter folded was Mid Florida.

1/30/2019 Jack: I will look in to That Roberta. I am on the road now. As to the posting of revised minutes. Once minutes are approved, they will be posted on the web site.

I had advised Larry D that I would make the change he requested. I am not posting revised minutes during the voting process.

1/30/2019 Jack : Roberta, I found the errors you mentioned. They will be corrected in the Minutes prior to posting.

1/30/2019 Larry S: Jack, Could you please send out the corrected minutes so we can review the corrections before we vote on them?

2/1/2019 Just so we are all clear on what voting to approve minutes constitutes. The Minutes are meant to act as a record of actions taken by as BOD. They are not meant to record entire conversations. True minutes are not sentences, they are an encapsulation of relevant discussions and are meant to provide a record of motions and action taken. Prior minutes have frankly been way too wordy. That leads to irrelevant conversations and issues that hinder the reporting the work of the BOD. I have made a concentrated effort in reducing that verbiage and will continue to reduce it even further. The discussion going on at the moment is an example of what should not be going on. The intent of minutes is to record actions, such as the choosing of a new BCA office, how the members voted for that and the result. Period.

To vote against those minutes may in fact be to vote against that action being a valid BOD action.

As I have stated , the proper thing to be doing at them moment is to vote for the Minutes and incorporate the changes into the final ruling . For example .The President would rule that the minutes of Sept, Oct. and Nov. 2018 are accepted with the inclusion of the three corrections. October minutes to include : Larry D stated; "in my view this (Jack Gerskemper's report) not to be even considered on its validity". November Minutes to include a typo correction from and a correction of the failed Florida Chapter to Mid Florida.

If a BOD Member is not comfortable with this, I would recommend that they simply abstain from voting and let the Board get on with business.

Larry D: Thank you Jack for your opinion.

Since I have been on the board whenever there had been a correction done to the minutes there was usually a verification and then we would all vote to **approve**. Usually with the note that there were corrections to the minutes.

Our experience with our previous secretary was that the minutes of any meeting (email or conference call) was usually submitted within several days. Once they were approved they were then posted on the website and made available for the membership.

I have had emails and calls of chapter Directors from B.O.O.M, Metro, and South Jersey Shore as well as repeated questions from our Mason-Dixon members. There questions are... Where are the minutes? Why have there not been anything recently posted? They have asked me to put forth a motion to have current Approved minutes communicated to them as soon as possible. I have had to put them off saying that the BOD had no minutes submitted to approve.

Next week we should just be receiving the January minutes, not October's then September's and lastly November's, not to mention December's.

2/1/2019 Jack : And so , the solution is to continue to delay the process?

2/1/2019 Jack : In the interest of getting these minutes approved and moving on to other business, I would ask President Alan to close this vote when the Floor closes for the weekend. I would suggest that there has been sufficient time for all BOD members to have made a decision.

2/1/2019 Larry D : Yes Jack, it appears that it is your solution. Please show us the corrected minutes so we can approve.

2/1/2019 Jack : I have already sent my corrections

2/1/2019 Larry S: Jack, It is simple. You have a credibility problem with some of us. On the last vote that we had rescinding the Denver action you said that if I changed the motion you would vote for the motion. I made the changes you asked for and you still voted no.

This is a problem. We would spend less time on this if you would just change the minutes as requested and resend them out.

2/1/2019: Jack : Larry S You have the right to vote yes , no or abstain. You do NOT have the right to level a personal attack on me. This is a new low in the bully tactics employed by certain BOD members to get their way.

2/2/2019 President Alan: The floor closed Friday night. With that, the vote is done. We had a full 24 hours for discussion, and then a full 48 hours to vote.

They are not meant to record entire conversations. True minutes are not sentences, they are an encapsulation of relevant discussions and are meant to provide a record of motions and action taken. Prior minutes have frankly been way too wordy. That leads to irrelevant conversations and issues that hinder the reporting the work of the BOD. I have made a concentrated effort in reducing that verbiage and will continue to reduce it even further. The discussion going on at the moment is an example of what should not be going on. The intent of minutes is to record actions, such as the choosing of a new BCA office, how the members voted for that and the result. Period.

To vote against those minutes may in fact be to vote against that action being a valid BOD action.

As I have stated, the proper thing to be doing at them moment is to vote for the Minutes and incorporate the changes into the final ruling. For example. The President would rule that the minutes of Sept, Oct. and Nov. 2018 are accepted with the inclusion of the three corrections. October minutes to include : Larry D stated; "in my view this (Jack Gerskemper's report) not to be even considered on its validity". November Minutes to include a typo correction from and a correction of the failed Florida Chapter to Mid Florida.
