Despite issues continuing with the IRS, our CPA firm has advised us to continue to file as a Non Profit as we have in the past. It is expected that this issues will straighten themselves out.

We did receive a letter from the IRS stating, they had received our 2019 filings, but they feel we owe them $\$ 561.00$ to settle our account. It was decided that that may also be incorrect, so Jerry will investigate, and pay that going forward if necessary before the due date.

Jerry is putting together a strategic financial plan for the Club. It is felt that although premature, an item for the Museum should be included in the plan.

Insurance. Jack introduced our insurance agent Jeff Demarey from Stonewall Insurance. Jeff proposed that the Club omit one step in the insurance plan and have Stonewall be our direct agent with our Insurance carriers. We currently use Hagerty as a middleman. Taking Hagerty out of the equation. Our policy will remain exactly as it is, our policy number will remain the same. Jeff as a Hagerty agent mentioned that they have no issue wit us doing that. It will reduce the number of people in the chain.
The BOD discussed the advantages and disadvantages of both scenarios. The BOD is still recovering from the former scenario where Chubb Insurance did not do a good job for the Club. Jerry moved to accept the Stonewall proposal. $2^{\text {nd }}$ John

SOP committee John asked to have a box of Bugles sent to the Lisle Meet, because the changes are already in print in the latest issue. That will provide the opportunity for any member wishing to see them in print. There is a possible paper shortage coming , so anything we can do to reduce unnecessary paper is a positive. It appears that our paper costs may increase going forward.

NMC. Marck indicated. Jack will serve as Meet Chief judge for the Spokane National Meet. There are no changes proposed for Lisle.

Gilmore / Museum committee. Bob indicated the Committee has already met twice. The BHA will assist in any fundraising and the Committee wants to have Richard Sills write up an agreement between the BHA and the BCA in case the proposal starts to move forward. Rob Mauser would review the agreement. The Committee currently consists of Bob as chair, Melanie, Mike, Jack, Sid and Alan Oldfield.

Jack will design a handout flyer to be given out at Lisle for members to get information on the concept and early design thoughts that the museum may take. Bob has met with the management of the Gilmore and it appears that there are also ongoing discussions about a muscle car museum and a HCCA Museum.

New Business. Sid is advocating for E members to have an easy method of voting in BCA elections. Our current Office managers Cornerstone has a system in place, that they could put in place for us for a flat fee of $\$ 500$.
